LEGAL DESCRIPTION

Being a parcel of land situated in the southwest quarter of Section 33, Richland Township, Town-2-South, Range-12-East, Wyandot County, Ohio described as follows:

BEGINNING at a found iron pipe marking the north eighth (1/8) post of the southwest quarter of said section and the centerline of County Highway 79; thence **N 89° 48' 19" E** five hundred ninety-two and ninety-one hundredths (592.91) feet along the east-west quarter (1/4) section line to a set iron rod;

thence **S 00° 06' 26" E** one hundred eighty-one and seventy-three hundredths (181.73) feet to a set iron rod;

thence **S 89° 03' 04" W** five hundred ninety-two and six hundredths (592.06) feet to a set P-K nail on north-south eighth line of the southwest quarter and on the centerline County Highway 79, passing at five hundred seventy-two and six hundredths (572.06) feet a set iron rod on line for reference;

thence **N 00° 22' 56" W** one hundred eighty-nine and fifty-two hundredths (189.52) feet along said eighth (1/8) line and said centerline to **THE POINT OF BEGINNING**.

Containing in all, 2.525 acres of land, more or less, subject to all legal highways and easements.

BEGINNING at a found iron pipe marking the center of said section; thence S 89° 48' 19" W twenty-seven and ninety-four hundredths (27.94) feet along the east-west quarter (1/4) section line;

thence N 44° 06' 18" E thirty-nine and three hundredths (39.03) feet to the north-south quarter (1/4) section line;

thence S 01° 35' 43" E twenty-seven and ninety-four hundredths (27.94) feet along the north-south quarter (1/4) section line to THE POINT OF BEGINNING.

Containing in all, 0.009 acres of land, more or less, subject to all legal highways and easements.
