**LEGAL DESCRIPTION OF A 1.601 ACRE PARCEL
FOR MARLENE SWINEHART**

Being a parcel of land situated in part of the Southwest Quarter of Section 1, T-3-S, R-14-E, Crane Township, Wyandot County, Ohio, and further described as follows:

Commencing at a found stone marking the center of said Section 1;

thence on an assumed bearing of S 00° 06' 43" E along the north-south half section line of said Section 1 and the centerline of Township Highway 127 a distance of 646.49 feet to a set iron rod and being the **POINT OF BEGINNING** of the hereinafter described parcel;

thence continuing S 00° 06' 43" E along said north-south half section line and said centerline of Township Highway 127 a distance of 200.01 feet to a point marking the northeast corner of a parcel of land now or formerly owned by N. Swinehart, referenced by a found iron pipe situated N 89° 48' 41" W a distance of 20.05 feet;

thence N 89° 41' 12" W along the north line of said Swinehart parcel a distance of 348.66 feet to a found iron pipe marking the northwest corner of said Swinehart parcel, passing a found P-K nail a distance of 0.07 feet;

thence N 00° 06' 43" W a distance of 200.01 feet to a set iron rod;

thence S 89° 41' 12" E a distance of 348.66 feet to the **POINT OF BEGINNING**.

Containing in all 1.601 acres of land, more or less, of which 0.092 acre, more or less, is currently contained within highway right-of-ways. The above described property being subject to all legal highways and easements of record.

Bearings are assumed and are for angular measurement only.

All set iron rods are 5/8" diameter with personalized plastic caps.


