**LEGAL DESCRIPTION OF A 2.000 ACRE PARCEL  
FOR FRANK FOX**

Being a parcel of land situated in part of the Northeast Quarter of Section 10, T-3-S, R-12-E, Jackson Township, Wyandot County, Ohio, and further described as follows:

Commencing at a found railroad spike marking the north quarter post of said Section 10, referenced by a found iron rod situated S 32° 44' 57" E a distance of 35.95 feet;

thence on an assumed bearing of S 89° 18' 52" E along the centerline of State Highway 53 and the north line of said Section 10 a distance of 682.58 feet to a found MAG nail, and being the **POINT OF BEGINNING** of the hereinafter described parcel, referenced by a found iron rod situated S 00° 41' 08" W a distance of 30.00 feet;

thence continuing S 89° 18' 52" E along the centerline of State Highway 53 and the north line of said Section 10 a distance of 313.00 feet to a found MAG nail, referenced by a found iron rod situated S 00° 41' 08" W a distance of 30.00 feet;

thence S 00° 41' 08" W on a line a distance of 278.34 feet to a set iron rod, passing the aforementioned found iron rod a distance of 30.00 feet;

thence N 89° 18' 52" W on a line a distance of 313.00 feet to a set iron rod;

thence N 00° 41' 08" E on a line a distance of 278.34 feet to the **POINT OF BEGINNING**, passing a found iron rod a distance of 248.34 feet.

Containing in all 2.000 acres of land, more or less, of which 0.216 acre, more or less, is currently contained within highway right-of-ways. The above described property being subject to all legal highways and easements of record.


Bearings are assumed and are for angular measurement only.
