LEGAL DESCRIPTION

Situated in the Village of Carey, County of Wyandot, State of Ohio and being a part of Lot 4 as platted in the Sheriden Subdivision recorded in Cabinet A, Slides 768 and 769 in the Wyandot County Recorder's Office, a tract of land bounded and described as follows:

Commencing at a 5/8" iron pin found with PAI cap marking the southwest corner of said Lot 4;

thence along a westerly line of said Lot 4 also being the easterly right of way line of Sheriden Drive (60' R/W) as platted in said Sheriden Subdivision N14°57'16"W a distance of 7.89 feet to a 5/8" iron pin found with PAI cap marking the PC of a curve segment to the left;

thence along said curve segment to the left, in a northwesterly direction with a central angle of 3°40'06" a radius of 580.00 feet and a length of curve of 37.14 feet, the chord of said curve segment bearing N16°47'19"W a distance of 37.13 feet to a 5/8" iron pin found with unidentifiable orange cap and being the Principal Point of Beginning of the tract of land to be herein described, said beginning point also being the northwest corner of a 0.210 acre tract of land conveyed to Casey's Marketing Company in OR 255, Page 2050 of the Wyandot County Official Records;

thence from the above described Principal Point of Beginning, and continuing along the easterly right of way line of said Sheriden Drive, along a curve segment to the left, in a northwesterly direction, with a central angle of 11°08'07" a radius of 580.00 feet and a length of curve of 112.72 feet, the chord of said curve segment bearing N24°11'26"W a distance of 112.54 feet to an iron pin set;

thence leaving the easterly right of way line of said Sheriden Drive N73°45'48"E a distance of 222.31 feet to a 5/8" iron pin found marking a corner of said Lot 4;

thence along a easterly line of said Lot 4 S14°57'16"E a distance of 116.06 feet to a 5/8" iron pin found with PAI cap marking the northeast corner of said 0.210 acre tract;
