**LEGAL DESCRIPTION OF A 4.015 ACRE PARCEL
FOR BRANDON STINE**

Being a parcel of land situated in part of the Southeast Quarter of Section 15, T-1-S, R-15-E, Sycamore Township, Wyandot County, Ohio, and further described as follows:

Commencing at a stone marking the southeast corner of said Section 15 and the intersection of the centerlines of State Highway 103 and Township Highway 10;

thence on an assumed bearing of N 89° 24' 28" W along the centerline of said State Highway 103 a distance of 1006.16 feet to a set MAG nail and being the **POINT OF BEGINNING** of the hereinafter described parcel, referenced by a set iron rod situated N 00° 20' 42" E a distance of 30.00 feet;

thence continuing N 89° 24' 28" W along said State Highway 103 a distance of 319.54 feet to a set MAG nail marking a corner of a parcel of land now or formerly owned by J. J. Stober;

thence N 00° 20' 42" E along said J. J. Stober parcel a distance of 540.00 feet to a set iron rod, passing a set iron rod a distance of 30.00 feet;

thence N 87° 57' 51" E on a line a distance of 319.82 feet to a set iron rod;

thence S 00° 20' 42" W on a line a distance of 554.66 feet to the **POINT OF BEGINNING**.

Containing in all 4.015 acres of land, more or less, of which 0.220 acre, more or less, is currently contained within highway right-of-ways. The above described property being subject to all legal highways and easements of record.

Bearings are assumed and are for angular measurement only.

All set iron rods are 5/8" diameter with personalized plastic caps.
