**LEGAL DESCRIPTION OF A 2.342 ACRE PARCEL
FOR MARGRAF TRUST**

Being a parcel of land situated in part of the Northeast Quarter of Section 1, T-2-S, R-14-E, Eden Township, Wyandot County, Ohio, and further described as follows:

Commencing at a found stone marking the north quarter post of said Section 1 and the centerline of County Highway 39;

thence on an assumed bearing of S 89° 10' 28" E along the north line of said Section 1 and the centerline of said County Highway 39 a distance of 1138.45 feet to a set MAG nail and being the **POINT OF BEGINNING** of the hereinafter described parcel, referenced by a set iron rod situated S 00° 49' 03" W a distance of 20.00 feet;

thence continuing S 89° 10' 28" E along the north line of said Section 1 and the centerline of said County Highway 39 a distance of 200.00 feet to a set MAG nail;

thence S 00° 49' 03" W on a line a distance of 510.00 feet to a set iron rod, passing a set iron rod a distance of 20.00 feet;

thence N 89° 10' 28" W on a line a distance of 200.00 feet to a set iron rod;

thence N 00° 49' 03" E on a line a distance of 510.00 feet to the **POINT OF BEGINNING**, passing a set iron rod a distance of 490.00 feet

Containing in all 2.342 acres of land, more or less, of which 0.092 acre, more or less, is currently contained within highway right-of-ways. The above described property being subject to all legal highways and easements of record.

Bearings are assumed and are for angular measurement only.

All set iron rods are 5/8" diameter with personalized plastic caps.
