**LEGAL DESCRIPTION OF A 5.292 ACRE PARCEL
FOR TAYLOR KIN**

Being a parcel of land situated in part of the Northeast Quarter of Section 12, T-2-S, R-12-E, Richland Township, Wyandot County, Ohio, and further described as follows:

Commencing at a found stone marking the east quarter post of said Section 12 and the centerline of County Highway 95;

thence on an assumed bearing of N 00° 17' 55" W along the east line of said Section 12 and the centerline of said County Highway 95 a distance of 322.92 feet to a set MAG nail and being the **POINT OF BEGINNING** of the hereinafter described parcel;

thence N 89° 27' 33" W on a line a distance of 325.03 feet to a set iron rod, passing a set iron rod a distance of 20.00 feet;

thence S 00° 17' 55" E on a line a distance of 322.73 feet to a set iron rod marking the east - west ½ section line of said section 12;

thence N 89° 25' 37" W along said line a distance of 600.00 feet to set iron rod;

thence N 00° 17' 55" W on a line a distance of 362.40 feet to a set iron rod marking the south line of a parcel of land now or formerly owned by Ann E. Suber, Trustee;

thence S 89° 27' 33" E along the south line of said Ann E. Suber, Trustee parcel a distance of 925.01 feet to the east line of said Section 12 and the centerline of County Highway 95, passing a found iron rod a distance of 905.01 feet;

thence S 00° 17' 55" E along the east line of said Section 12 and the centerline of said County Highway 95 a distance of 40.00 feet to the **POINT OF BEGINNING**.

Containing in all 5.292 acres of land, more or less, of which 0.018 acre, more or less, is currently contained within highway right-of-ways. The above described property being subject to all legal highways and easements of record.

Bearings are assumed and are for angular measurement only.

All set iron rods are 5/8" diameter with personalized plastic caps.
