BEGINNING**, passing 2 set MAG nails a distance of 455.13 feet and 882.77 feet
respectively;

thence N 89° 50' 57" W a distance of 285.85 feet to a set iron rod, passing a set iron rod a
distance of 30.00 feet;

thence N 00° 29' 44" E a distance of 361.98 feet to a set iron rod;

thence S 89° 50' 57" E a distance of 285.85 feet to a set MAG nail on the centerline of
County Highway 96, passing a set iron rod a distance of 255.85 feet;

thence S 00° 29' 44" W along said centerline a distance of 361.98 feet to the **POINT OF
BEGINNING**.

Containing in all 2.375 acres of land, more or less, of which 0.249 acres, more or less, is
currently contained within the right-of-way of County Highway 96. The above described
