Commencing at a stone in a monument box marking the southeast corner of said Section 28 and the centerline intersection of State Route 231 and County Highway 36;

thence S $89^{\circ} 53' 43''$ W four hundred twenty-two and zero hundredths (422.00) feet along the south line of Section 28 and the centerline of County Highway 36 to a set nail, **THE POINT OF BEGINNING**;

thence S $89^{\circ} 53' 43''$ W nine hundred five and sixty-four hundredths (905.64) feet along the south line of Section 28 and the centerline of County Highway 36 to a found stone in a monument box marking the south eighth post of said Southeast quarter;

thence N $00^{\circ} 03' 31''$ E one thousand five hundred fifty-six and seventy-three hundredths (1556.73) feet along the north-south eighth line of said Southeast quarter to the centerline of a ditch referenced by a set iron rod N $00^{\circ} 03' 31''$ E at sixteen and fifty-two hundredths (16.52) feet and passing a set iron rod for reference at thirty-one and twenty-one hundredths (31.21) feet;

thence S $59^{\circ} 33' 21''$ E seventy-seven and fourteen hundredths (77.14) feet along the centerline of said ditch referenced by a set iron rod N $06^{\circ} 58' 13''$ W at nineteen and twenty-nine hundredths (19.29) feet;



Commencing at a nail found over a stone at the Northeast corner of said section;

thence on an assumed bearing of North 90 degrees, 00 minutes, 00 seconds West, along the North Section line and the centerline of State Route 103, (This bearing is based on the North Section Line and assumed centerline of State Route 103, and all other bearings are from angles and distances measured in the field.), for a distance of 1325.68 feet to a nail set on the R. Reis Etal. West line;

thence South 00 degrees, 02 minutes, 05 seconds, East on said line for a distance of 30.00 feet to a personalized half inch iron pipe set with a cap;

thence South 00 degrees, 02 minutes, 05 seconds, East on said line and of wire fence line, for a distance 902.02 feet to a personalized half inch iron pipe set with cap, The place of beginning;

Thence South 00 degrees, 26 minutes, 22 seconds, East on said line for a distance of 386.97 feet to a point referenced by a personalized half inch pipe set with cap North 00 degrees, 26 minutes, 22 seconds West a distance of 6.16 feet.



thence North 00 degrees, 36 minutes, 51 seconds East on a line for a distance of 389.50 feet to a personalized half inch iron pipe set with cap;




