Commencing at a iron pipe in a monument box marking the South Quarter Post of said Section;

thence on an assumed bearing of N 00° 00' 00" E along the centerline of Township Highway 95 a distance of 566.62 feet to a set MAG nail and being the **POINT OF BEGINNING**, passing a found P-K nail a distance of 200.00 feet;

thence continuing N 00° 00' 00" E along said centerline a distance of 200.00 feet to a found MAG nail marking the southwest corner of a parcel of land currently owned by John D. Perkins;

thence N 85° 58' 00" E along the south line of said Perkins parcel a distance of 205.00 feet to a set iron rod, passing a set iron rod a distance 20.05 feet;

thence S 00° 00' 00" W a distance of 200.00 feet to a set iron rod;

thence S 85° 58' 00" W a distance of 205.00 feet to the **POINT OF BEGINNING**, passing a set iron rod a distance of 184.95 feet.

Containing in all 0.939 acre of land, more or less, of which 0.092 acre, more or less, is currently contained within the right-of-way of Township Highway 95. The above described property being subject to all legal highways and easements of record.

thence N 85° 58' 00" E a distance of 205.00 feet to a set iron rod, passing a set iron rod a distance 20.05 feet;

thence S 00° 00' 00" W a distance of 200.75 feet to a set iron rod on the north line of said Tong parcel;

thence S 86° 10' 30" W along the north line of said Tong parcel a distance of 204.95 feet to the **POINT OF BEGINNING**, passing a set iron rod a distance of 184.90 feet.
