SITUATED IN THE STATE OF OHIO, COUNTY OF WYANDOT, CITY OF UPPER SANDUSKY, BEING PART OF THE NORTHEAST QUARTER OF SECTION 33, TOWNSHIP 2 SOUTH, RANGE 14 EAST, BEING 5.986 ACRES OUT OF A 6.604 ACRE TRACT CONVEYED TO THE TRUSTEES OF TRINITY EVANGELICAL CHURCH OF RECORD IN DEED BOOK 214, PAGE 494, AND A 10.00 ACRE TRACT CONVEYED TO THE TRUSTEES OF TRINITY EVANGELICAL CHURCH OF RECORD IN DEED BOOK 210, PAGE 832, RECORDS REFER TO THE COUNTY RECORDER'S OFFICE, WYANDOT COUNTY, OHIO, AND BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

BEGINNING FOR REFERENCE AT A RAILROAD SPIKE FOUND AT THE CENTERLINE OF COUNTY ROAD 121 (60 FEET IN WIDTH) AND EAST WYANDOT AVENUE (RIGHT-OF-WAY VARIES), SAID RAILROAD SPIKE BEING REFERENCED BY A ½" IRON PIN FOUND MARKED "VBK 7457" AT SOUTH 00°53'32" EAST, A DISTANCE OF 73.04 FEET;

THENCE SOUTH 00°53'32" EAST, A DISTANCE OF 73.04 FEET WITH THE NORTH-SOUTH HALF SECTION LINE OF SAID SECTION 33 TO A ½" IRON PIN FOUND MARKED "VBK 7457" IN THE SOUTHERLY RIGHT-OF-WAY LINE OF SAID EAST WYANDOT AVENUE;

THENCE SOUTH 00°53'32" EAST, A DISTANCE OF 397.84 FEET WITH THE NORTH-SOUTH HALF SECTION LINE OF SAID SECTION 33 TO A ½" IRON PIN FOUND MARKED "VBK 7457" ON A NORTH LINE OF A TRACT CONVEYED TO PAUL R. HILDERBRAND, ETAL OF RECORD IN DEED BOOK 176, PAGE 708;

THENCE NORTH 89°06'28" EAST, A DISTANCE OF 111.36 FEET WITH THE NORTH LINE OF SAID HILDERBRAND TRACT TO A 5/8" IRON PIN FOUND MARKED "MAKEEVER & ASSOC." AT THE NORTHEAST CORNER OF SAID TRACT AT THE POINT OF BEGINNING;

THENCE NORTH 00°09'49" WEST, A DISTANCE OF 65.99 FEET OVER AND ACROSS SAID TRINITY EVANGELICAL CHURCH TRACT TO AN IRON PIN SET;

THENCE NORTH 89°50'11" EAST, A DISTANCE OF 512.18 FEET OVER AND ACROSS SAID TRINITY EVANGELICAL CHURCH TRACT TO AN IRON PIN SET ON THE WEST RIGHT-OF-WAY OF MALABAR DRIVE (60 FEET IN WIDTH);

THENCE SOUTH 00°09'49" EAST, A DISTANCE OF 266.12 FEET WITH THE WEST RIGHT-OF-WAY LINE OF SAID MALABAR DRIVE (PASSING A 5/8" IRON PIN FOUND MARKED "MAKEEVER & ASSOC." AT 59.48 FEET) TO AN IRON PIN SET;

THENCE SOUTH 00°46'08" EAST, A DISTANCE OF 238.81 FEET WITH THE WEST RIGHT-OF-WAY LINE OF SAID MALABAR DRIVE TO AN IRON PIN SET;

THENCE SOUTH 89°02'57" WEST, A DISTANCE OF 514.75 FEET OVER AND ACROSS SAID TRINITY EVANGELICAL CHURCH TO AN IRON PIN SET ON AN EAST LINE OF SAID HILDERBRAND TRACT;

THENCE NORTH 00°09'49" WEST, A DISTANCE OF 446.00 FEET WITH AN EAST LINE OF SAID HILDERBRAND TRACT TO THE IRON PIN FOUND AT THE POINT OF BEGINNING, AND CONTAINING 5.986 ACRES OF LAND, MORE OR LESS.
