thence on an assumed bearing of S $87^{\circ} 37' 24''$ W along the centerline of County Highway 39 a distance of 300.17 feet to a set MAG nail;

thence N $00^{\circ} 00' 00''$ E a distance of 276.51 feet to a set iron rod, passing a set iron rod a distance of 30.03 feet;

thence S $89^{\circ} 55' 14''$ E a distance of 299.91 feet to a set MAG nail on the centerline of State Route 231 marking the southeast corner of a parcel of land currently owned by J. R. Beach, passing a found iron pipe marking the southwest corner of said Beach parcel a distance of 99.91 feet and passing a found iron pipe a distance of 265.43 feet;

thence S $00^{\circ} 00' 00''$ W along said centerline a distance of 263.65 feet to the **POINT OF BEGINNING**.
