thence on an assumed bearing of S 89° 31' 06" W a distance of 29.43 feet to a found iron rod on the west line of said Wood parcel;

thence N 00° 28' 54" W along the west line of said Wood parcel a distance of 64.75 feet to a set iron rod;

thence N 89° 30' 29" E a distance of 28.65 feet to a set iron rod on the west line of said Lot #5;

thence S 01° 10' 48" E along the west line of said Lot #5 a distance of 64.76 feet to the **POINT OF BEGINNING**.

Containing in all 0.043 acre of land, more or less, being subject to all legal highways and easements of record.

thence S 89° 30' 29" W a distance of 28.65 feet to a set iron rod on the west line of said Wood parcel;

thence N 00° 28' 54" W along the west line of said Wood parcel a distance of 64.75 feet to a point, referenced by a found iron pipe situated N 89° 31' 06" E a distance of 27.86 feet;

thence N 89° 31' 06" E a distance of 27.86 feet to the **POINT OF BEGINNING**.
