Commencing at a set MAG nail marking the intersection of the north-south half section line of said Section 13 and the centerline of Township Highway 18, referenced by a set iron rod situated N 00° 17' 29" E a distance of 16.50 feet;

thence on an assumed bearing of N 89° 42' 15" W along the centerline of Township Highway 18 a distance of 60.00 feet to a set MAG nail and being the **POINT OF BEGINNING**, referenced by a set iron rod situated N 00° 17' 29" E a distance of 16.50 feet;

thence continuing N 89° 42' 15" W along said centerline a distance of 993.13 feet to a set MAG nail;

thence N 00° 14' 44" E a distance of 595.86 feet to a set iron rod, passing a set iron rod a distance of 16.50 feet;

thence S 85° 56' 56" E a distance of 275.00 feet to a set iron rod;

thence S 20° 23' 31" E a distance of 72.66 feet to a set iron rod;

thence S 00° 47' 56" W a distance of 294.24 feet to a set iron rod;

thence S 43° 08' 38" E a distance of 58.45 feet to a set iron rod;

thence S 88° 31' 41" E a distance of 308.26 feet to a set iron rod;

thence S 71° 07' 41" E a distance of 366.89 feet to a set iron rod;

thence S 00° 17' 29" W a distance of 50.00 feet to the **POINT OF BEGINNING**, passing a set iron rod a distance of 33.50 feet.

thence N 00° 17' 29" E a distance of 50.00 feet to a set iron rod, passing a set iron rod a distance of 16.50 feet;

thence N 71° 07' 41" W a distance of 366.89 feet to a set iron rod;

thence N 88° 31' 41" W a distance of 308.26 feet to a set iron rod;

thence N 43° 08' 38" W a distance of 58.45 feet to a set iron rod;
