PARCEL 1 LEGAL DESCRIPTION

Being a parcel of land situated in part Lot 2 of Simonis Subdivision and the west part of the northeast quarter of the southeast quarter of Section 17, Crawford Township, Township—1—South, Range—13—East, Wyandot County, Ohio, described as follows:

Commencing at a found iron rod marking the northwesterly corner of said Lot 2 and the southerly right-of-way of West North Street;

thence **S 78° 36' 56" E** nine and seventy-six hundredths (9.76) feet along the northerly line of Lot 2 and said right-of-way to a set iron rod, **THE POINT OF BEGINNING**;

thence **S 78° 36' 56" E** fifty and four hundredths (50.04) feet along said lot line and said right-of-way to a found iron rod marking the northeasterly corner of said Lot 2;

thence **S 09° 49' 23" W** one hundred sixty-five and nine hundredths (165.09) feet along the easterly line of Lot 2 to a found iron pipe marking the a northeasterly corner of a parcel of land now or formerly owned by James Anderson et ux as described in Wyandot County Deed Volume 184, page 540;

thence **N 77° 39' 49" W** thirty and fifty-eight hundredths (30.58) feet along the northerly line of said Anderson's parcel to a found iron rod marking a northwesterly corner thereof and an easterly line of a parcel of land now or formerly owned by James Anderson et ux as described in Wyandot County Deed Volume 184, page 540;

thence **N 00° 11' 59" W** fourteen and forty-one hundredths (14.41) feet along an easterly line of said Anderson's parcel to the northeasterly corner thereof from which a found iron pipe for reference bears **N 77° 55' 44" W** three and seventy-one hundredths (3.71) feet

thence **N 77° 58' 41" W** nineteen and eight hundredths (19.08) feet along a northerly line of said Anderson's parcel to a set iron rod;

thence **N 10° 37' 28" E** one hundred fifty and twenty-one hundredths (150.21) feet to **THE POINT OF BEGINNING**.

Containing in all, **0.187** acres of land, more or less, subject to all legal highways and easements.

The bearing of West North Street is assumed S 78° 36' 56" E.

Bearings are assumed and for angular measurement only.

All iron rods set are 5/8" diameter by 30" length with personalized caps marked HANK AND ASSOC. Driven flush.

PARCEL 2 LEGAL DESCRIPTION

Commencing at a found iron rod marking the northwesterly corner of said Lot 2 and the southerly right-of-way of West North Street;

thence S 78° 36' 56" E nine and seventy-six hundredths (9.76) feet along the northerly line of said Lot 2 and said right-of-way to a set iron rod, **THE POINT OF BEGINNING**;

thence S 10° 37' 28" W one hundred fifty and twenty-one hundredths (150.21) feet to a set iron rod marking a northerly line of a parcel of land now or formerly owned by James Anderson et ux as described in Wyandot County Deed Volume 184, page 540;

thence N 77° 58' 41" W forty-six and ninety-three hundredths (46.93) feet along a northerly line of said Anderson's parcel to a found iron pipe marking the easterly line of a parcel of land now or formerly owned by Arba Row, Jr. Et ux as described in Wyandot County Official Record Volume 50, page 502;

thence N 00° 20' 00" W one hundred fifty-two and eighty-six hundredths (152.86) feet along the easterly line of said Row's parcel to a found iron rod marking the southerly right-of-way of West North Street;

thence S 78° 36' 56" E seventy-five and ninety-eight hundredths (75.98) feet along said right-of-way to **THE POINT OF BEGINNING**.

Containing in all, 0.211 acres of land, more or less, subject to all legal highways and easements.

The bearing of West North Street is assumed S 78° 36' 56" E.
