

LEGAL DESCRIPTION

Being a parcel of land situated in the northwest quarter of Section 16, Sycamore Township, Township-1-South, Range-15-East, Wyandot County, Ohio, described as follows:

Commencing at a found nail marking the north quarter post of said Section 16 and the centerline of County Highway 16 from which a set iron rod for reference bears S 00° 00' 00" E 16.50 feet;

thence S 90° 00' 00" W eight hundred ninety and zero hundredths (890.00) feet along the north line of said Section 16 and the centerline of County Highway 16 to a set nail, **THE POINT OF BEGINNING** from which a set iron rod for reference bears S 00° 00' 00" E 16.50 feet;

thence S 00° 00' 00" E three hundred twenty and forty-one hundredths (320.41) feet to a set iron rod, passing a set iron rod marking the southerly right-of-way of said highway at 16.50 feet;

thence S 90° 00' 00" W two hundred fifteen and zero hundredths (215.00) feet to a set iron rod;

thence N 00° 00' 00" W three hundred twenty and forty-one hundredths (320.41) feet to a set nail marking the north line of said Section 16 and the centerline of County Highway 16, passing a set iron rod marking the southerly right-of-way of said highway at 303.91 feet;

thence N 90° 00' 00" E forty-nine and zero hundredths (49.00) feet along said section line and said centerline to a set nail marking the northwesterly corner of a 0.60 acre parcel of land now or formerly owned by Norman Cassidy et ux as described in Wyandot County Deed Volume 143, page 28 from which a set iron rod for reference bears S 00° 00' 00" E 16.50 feet;

thence S 00° 00' 00" W two hundred ten and zero hundredths (210.00) feet along the westerly line of said Cassidy's 0.60 acre parcel to a set iron rod marking the southwesterly corner thereof, passing a set iron rod marking the southerly right-of-way of said highway at 16.50 feet;

thence N 90° 00' 00" E one hundred twenty-four and zero hundredths (124.00) feet along the southerly line of said Cassidy's 0.60 acre parcel to a set iron rod marking the southeasterly corner thereof;

thence N 00° 00' 00" W two hundred ten and zero hundredths (210.00) feet along the easterly line of said Cassidy's 0.60 acre parcel to a set nail marking the northeasterly corner thereof, the north line of said Section 16 and the centerline of County Highway 16, passing a set iron rod marking the southerly right-of-way of said highway at 193.50 feet;

thence N 90° 00' 00" E forty-two and zero hundredths (42.00) feet along said section line and said centerline to **THE POINT OF BEGINNING**.

Containing in all, **0.984** acres of land, more or less, subject to all legal highways and easements. There are 0.034 acres of the 0.984 acre parcel in the road right-of-way.

The bearing of the centerline of County Highway 16 is assumed S 90° 00' 00" W.

Bearings are assumed and for angular measurement only.

All iron rods set are 5/8" diameter by 30" length with personalized caps marked HANK AND ASSOC. driven flush.
