thence on an assumed bearing of S 00° 00' 00" W along the east line of said Lot #6 a distance of 34.00 feet to a found iron rod on the north line of a parcel of land currently owned by J. M. Adams;

thence S 89° 50' 28" W along said Adams parcel a distance of 65.11 feet to a set iron rod;

thence N 00° 00' 00" E a distance of 117.55 feet to a set iron rod on the southerly right-of-way of an alley;

thence S 86° 00' 22" E along the southerly right-of-way line of said alley a distance of 65.27 feet to a point on the east line of Lot # 5 of said Addition, passing a found iron rod a distance of 55.27 feet;

thence S 00° 00' 00" W along the east line of said Lot #5 a distance of 78.82 feet to the **POINT OF BEGINNING**.

thence S 86° 00' 22" E along the southerly right-of-way line of said alley a distance of 123.18 feet to a set iron rod, passing a found iron rod a distance of 93.23 feet;
