thence S 02° 15' 04" W a distance of 230.92 feet to a set iron rod;

thence N 90° 00' 00" W a distance of 200.00 feet to a found iron rod on an easterly line  
of a parcel of land currently owned by M. Arnold;

thence N 02° 20' 41" E along said Arnold parcel a distance of 488.70 feet to a found iron  
rod;

thence S 87° 25' 17" E along said Arnold parcel a distance of 682.50 feet to a found iron  
rod on the east line of said Section 22;

thence S 02° 15' 04" W along said section line a distance of 227.02 feet to the **POINT  
OF BEGINNING**.

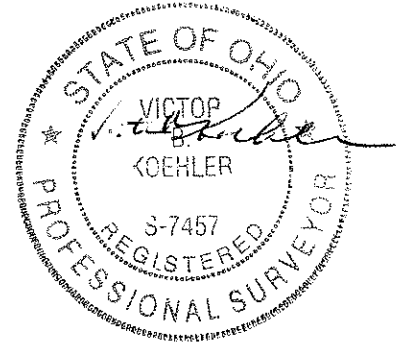

thence on an assumed bearing of N 90° 00' 00" W along the centerline of County  
Highway 64 a distance of 354.28 feet to a found nail;

thence N 00° 00' 00" E a distance of 175.00 feet to a found iron rod, passing a found iron  
rod for reference a distance of 25.00 feet;

thence N 90° 00' 00" W a distance of 122.66 feet to a set iron rod;

thence N 02° 15' 04" E a distance of 230.92 feet to a set iron rod;

thence S 90° 00' 00" E a distance of 483.82 feet to a set iron rod on the east line of said  
Section 22;

thence S 02° 15' 04" W along said section line a distance of 406.06 feet to the **POINT
