**LEGAL DESCRIPTION FOR DYLAN WYATT
2.755 ACRES
TOWNSHIP OF MIFFLIN, WYANDOT COUNTY, OHIO**

SITUATED IN THE STATE OF OHIO, COUNTY OF WYANDOT, TOWNSHIP 3 SOUTH, RANGE 13 EAST, TOWNSHIP OF MIFFLIN, BEING PART OF THE SOUTHWEST QUARTER OF SECTION 21, AND BEING A 2.755 ACRE TRACT OUT OF AN ORIGINAL TRACT CONVEYED TO JT WYATT PROPERTIES LLC, OF RECORD IN OFFICIAL RECORD 214, PAGE 1227, RECORDS REFER TO THE COUNTY RECORDER'S OFFICE, WYANDOT COUNTY, OHIO AND BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS;

BEGINNING FOR REFERENCE AT A RAILROAD SPIKE FOUND OVER STONE ON THE CENTERLINE OF COUNTY HIGHWAY 64 (50 FEET IN WIDTH), THE EAST CORNER OF SAID QUARTER, A SOUTHEAST CORNER OF SAID JT WYATT PROPERTIES TRACT, AND A SOUTHWEST CORNER OF A TRACT CONVEYED TO SCOTT MARSH, ETUX OF RECORD IN ORIGINAL RECORD 224, PAGE 1313;

THENCE NORTH $89^{\circ}43'36''$ WEST, A DISTANCE OF 150.00 FEET WITH THE CENTERLINE OF SAID COUNTY HIGHWAY 64, THE SOUTH LINE OF SAID QUARTER, THE SOUTH LINE OF SAID JT WYATT PROPERTIES TRACT, TO A MAG SPIKE SET AND BEING REFERENCED BY AN IRON PIN SET NORTH $00^{\circ}16'24''$ EAST, A DISTANCE OF 25.00 FEET, ALSO BEING THE POINT OF BEGINNING;

THENCE CONTINUING NORTH $89^{\circ}43'36''$ WEST, A DISTANCE OF 300.00 FEET WITH THE CENTERLINE OF SAID COUNTY HIGHWAY 64, THE SOUTH LINE OF SAID QUARTER, THE SOUTH LINE OF SAID JT WYATT PROPERTIES TRACT, TO A MAG SPIKE SET AND BEING REFERENCED BY AN IRON PIN SET NORTH $00^{\circ}16'24''$ EAST, A DISTANCE OF 25.00 FEET;

THENCE NORTH $00^{\circ}16'24''$ EAST, A DISTANCE OF 400.00 FEET OVER AND ACROSS SAID JT WYATT PROPERTIES TRACT, WITH A NEW LINE, PASSING AN IRON PIN SET AT 25.00 FEET ON THE NORTH RIGHT OF WAY LINE OF SAID COUNTY HIGHWAY 64, TO AN IRON PIN SET;

THENCE SOUTH $89^{\circ}43'36''$ EAST, A DISTANCE OF 300.00 FEET OVER AND ACROSS SAID JT WYATT PROPERTIES TRACT, WITH A NEW LINE, TO AN IRON PIN SET;



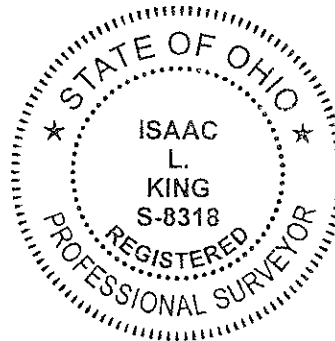
