**LEGAL DESCRIPTION OF A 5.249 ACRE PARCEL
FOR JEREMY MOUSER**

Being a parcel of land situated in the Southeast Quarter of Section 20 and Southwest Quarter of Section 21, T-3-S, R-15-E, Antrim Township, Wyandot County, Ohio, and further described as follows:

Beginning at a found stone marking the east quarter post of said Section 20 and the west quarter post of said Section 21 and being the **POINT OF BEGINNING** of the hereinafter described parcel;

thence on an assumed bearing of N 89° 24' 12" E along the east-west half section line of said Section 21 and the centerline of Township Highway 135 a distance of 72.00 feet to a set MAG nail, referenced by a set iron rod situated S 00° 23' 11" E a distance of 25.00 feet;

thence S 00° 23' 11" E on a line a distance of 355.86 feet to a set iron rod, passing the aforementioned set iron rod a distance of 25.00 feet;

thence N 89° 55' 21" W on a line a distance of 644.02 feet to a set iron rod;

thence N 00° 23' 11" W on a line a distance of 355.01 feet to a set iron rod marking the east-west half section line of said Section 20;

thence S 89° 55' 21" E along the east-west half section line of said Section 20 a distance of 572.02 feet to the **POINT OF BEGINNING**.

Containing in all 5.249 acres of land, more or less, of which 0.056 acre, more or less, is currently contained within highway right-of-ways. The above described property being subject to all legal highways and easements of record.


Bearings are assumed and are for angular measurement only.
