**LEGAL DESCRIPTION OF A 27.921 ACRE PARCEL
FOR DAVID NEFF**

Being a parcel of land situated in part of the Southeast Quarter of Section 25, T-1-S, R-13-E, Crawford Township, Wyandot County, Ohio, and further described as follows:

Beginning at a point marking the south quarter post of said Section 25 and being the **POINT OF BEGINNING** of the hereinafter described parcel, referenced by a found iron rod situated N 03° 31' 33" W a distance of 3.31 feet;

thence on an assumed bearing of N 00° 54' 05" E along the north-south half section line of said Section 25 a distance of 1309.25 feet to a point on the centerline of Township Highway 29, referenced by a found iron rod situated S 00° 25' 37" W a distance of 20.25 feet;

thence S 88° 57' 29" E along the centerline of said Township Highway 29, passing a found nail a distance of 0.17 feet a total distance of 919.13 feet to a set MAG nail, referenced by a set iron rod situated S 00° 08' 00" W a distance of 20.00 feet;

thence S 00° 08' 00" W on a line a distance of 1312.31 feet to a set iron rod marking the south line of said Section 25, passing the aforementioned set iron rod a distance of 20.00 feet;

thence N 88° 46' 52" W along the south line of said Section 25 a distance of 936.73 feet to the **POINT OF BEGINNING**.

Containing in all 27.921 acres of land, more or less, of which 0.422 acre, more or less, is currently contained within highway right-of-ways. The above described property being subject to all legal highways and easements of record.

Bearings are assumed and are for angular measurement only.

All set iron rods are 5/8" diameter with personalized plastic caps.
