**LEGAL DESCRIPTION OF A 0.639 ACRE PARCEL
FOR CLINT & LAUREN RICHEY**

Being a parcel of land situated in part of the Southeast Quarter of Section 4, T-3-S, R-14-E, Crane Township, Wyandot County, Ohio, and further described as follows:

Commencing at a found stone marking the center of said Section 4 and the centerline of County Highway 55;

thence on an assumed bearing of N 89° 47' 28" E along the east-west half section line of said Section 4 and centerline of said County Highway 55 a distance of 1172.00 feet to a set MAG nail and being the **POINT OF BEGINNING** of the hereinafter described parcel, referenced by a set iron rod a situated S 01° 12' 48" W a distance of 25.00 feet;

thence continuing N 89° 47' 28" E along the east-west half section line of said Section 4 and the centerline of County Highway 55 a distance of 65.00 feet to a point marking a corner of a parcel of land now or formerly owned by C. Richey, Etux., referenced by a set iron rod situated S 68° 56' 07" W a distance of 70.22 feet;

thence S 01° 12' 48" W along said C. Richey, Etux. parcel a distance of 428.37 feet to a found iron pipe marking a corner of said C. Richey, Etux. parcel, passing a found railroad spike at a distance of 2.26 feet;

thence S 89° 53' 48" W on a line a distance of 65.00 feet to a set iron rod;

thence N 01° 12' 48" E on a line a distance of 428.25 feet to the **POINT OF BEGINNING**, passing a set iron rod a distance of 403.25 feet.

Containing in all 0.639 acres of land, more or less, of which 0.037 acre, more or less, is currently contained within highway right-of-ways. The above described property being subject to all legal highways and easements of record.

Bearings are assumed and are for angular measurement only.

All set iron rods are 5/8" diameter with personalized plastic caps.
