

LEGAL DESCRIPTION

Being a parcel of land situated in the Village of Mexico, Tymochtee Township, Township-1-South, Range-14-East, Wyandot County, Ohio described as follows:

BEGINNING at a set iron rod marking the northwesterly corner of Lot 1 in said Village of Mexico and the easterly right-of-way of Sandusky Street (82.5 foot right-of-way);

thence **N 28° 24' 00"** E eight and twenty-five hundredths (**8.25**) feet along the easterly right-of-way of Sandusky Street to a found 1/2" diameter iron pipe marking the centerline of a vacated alley (16.5 foot wide) and the southerly line of a 1.74 acre parcel of land now or formerly owned by Robert and Kelli L. Cook as described in Wyandot County Official Record Volume 235, page 1445;

thence **S 61° 45' 40"** E two hundred ninety-one and sixty hundredths (**291.60**) feet along the centerline of said vacated alley and the southerly line of said Cook's 1.74 acre parcel to a set iron rod marking the southeasterly corner thereof and the east line of said Village of Mexico;

thence **S 00° 00' 00"** E nine and thirty-six hundredths (**9.36**) feet along the east line of said Village of Mexico to a set iron rod marking the northeasterly corner of said Lot 50 in said Village of Mexico;

thence **N 61° 45' 40"** W two hundred ninety-six and five hundredths (**296.05**) feet along the northerly line of said Lot 50 and the northerly lines of Lots 48 and 1 in said Village of Mexico to **THE POINT OF BEGINNING**.

Containing in all, **0.056** acres of land, more or less, subject to all legal highways and easements. The 0.056 acre parcel is part of parcel number: 38-2855-0000.

The bearing of the right-of-way of Sandusky Street is assumed N 28° 24' 00" E.
Bearings are assumed and for angular measurement only.

All iron rods set and found (unless noted) are 5/8" diameter by 30" in length with personalized caps marked Hank and ASSOC. driven flush.


