**LEGAL DESCRIPTION OF A 17.235 ACRE PARCEL
FOR VERA J. HUNTER**

Being a parcel of land situated in part of the Southwest and Northwest Quarters of Section 32, T-1-S, R-13-E, Crawford Township, Wyandot County, Ohio, and further described as follows:

Commencing at a found stone marking the west quarter post of said Section 32 and the centerline of County Highway 96 and being the **POINT OF BEGINNING** of the hereinafter described parcel;

thence on an assumed bearing of N 00° 07' 44" E along the west line of said Section 32 and the centerline of said County Highway 96 a distance of 786.00 feet to a set MAG nail;

thence S 87° 52' 01" E on a line a distance of 531.12 feet to a set iron rod, passing a set iron rod a distance of 30.02 feet;

thence S 00° 07' 44" W on a line a distance of 1410.28 feet to a found iron pipe marking a corner of a parcel of land now or formerly owned by J. Hunter, Etux.;

thence N 89° 07' 51" W along said J. Hunter, Etux. parcel a distance of 527.93 feet to a point marking the west line of said Section 32 and the centerline of said County Highway 96, passing a found iron pipe a distance of 508.33 feet and found MAG nail a distance of 526.04 feet;

thence N 00° 08' 00" W along the west line of said Section 32 and the centerline of said County Highway 96 a distance of 636.04 feet to the **POINT OF BEGINNING**.

Containing in all 17.235 acres of land, more or less, of which 0.979 acre, more or less, is currently contained within highway right-of-ways. The above described property being subject to all legal highways and easements of record.

Bearings are assumed and are for angular measurement only.

All set iron rods are 5/8" diameter with personalized plastic caps.
