**LEGAL DESCRIPTION FOR KODY WOLF
5.356 ACRES
SALEM TOWNSHIP, WYANDOT COUNTY, OHIO**

SITUATED IN THE STATE OF OHIO, COUNTY OF WYANDOT, SALEM TOWNSHIP, BEING PART OF THE SOUTHWEST QUARTER OF SECTION 4, TOWNSHIP 2 SOUTH, RANGE 13 EAST, BEING A 5.356 ACRE TRACT OUT OF A TRACT CONVEYED TO JEFFREY A. AND JACQUELINE S. WOLF OF RECORD IN DEED VOLUME 200, PAGE 595, RECORDS REFER TO THE RECORDER'S OFFICE, WYANDOT COUNTY, OHIO, BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

BEGINNING FOR REFERENCE AT A SURVEY NAIL FOUND OVER A STONE IN A MONUMENT BOX ON THE INTERSECTION OF CENTERLINES OF COUNTY HIGHWAY 97 (60 FEET IN WIDTH) AND TOWNSHIP HIGHWAY 42, THE SOUTHWEST CORNER OF SAID SOUTHWEST QUARTER, AND A SOUTHWEST CORNER OF SAID WOLF TRACT;

THENCE NORTH $00^{\circ}13'18''$ EAST, A DISTANCE OF 756.62 FEET WITH THE CENTERLINE OF SAID COUNTY HIGHWAY 97, THE WEST LINE OF SAID SOUTHWEST QUARTER, AND A WEST LINE OF SAID WOLF TRACT, TO A MAG SPIKE SET BEING REFERENCED BY AN IRON PIN SET NORTH $89^{\circ}55'38''$ EAST, A DISTANCE OF 30.00 FEET, SAID MAG SPIKE BEING THE POINT OF BEGINNING;

THENCE CONTINUING NORTH $00^{\circ}13'18''$ EAST, A DISTANCE OF 571.25 FEET WITH THE CENTERLINE OF SAID COUNTY HIGHWAY 97, THE WEST LINE OF SAID SOUTHWEST QUARTER, AND A WEST LINE OF SAID WOLF TRACT, TO A MAG SPIKE SET BEING REFERENCED BY AN IRON PIN SET SOUTH $89^{\circ}37'31''$ EAST, A DISTANCE OF 30.00 FEET, SAID MAG SPIKE BEING THE NORTHWEST CORNER OF THE SOUTH HALF OF SAID SOUTHWEST QUARTER, A NORTHWEST CORNER OF SAID WOLF TRACT, AND A SOUTHWEST CORNER OF A TRACT CONVEYED TO LEO J. AND ROSEMARY C. SMALLEY LIVING TRUST OF RECORD IN OFFICIAL RECORD 216, PAGE 1144;

THENCE SOUTH $89^{\circ}37'31''$ EAST, A DISTANCE OF 409.57 FEET WITH A NORTH LINE OF SAID WOLF TRACT AND A SOUTH LINE OF SAID SMALLEY TRACT, PASSING AN IRON PIN SET AT 30.00 FEET, TO AN IRON PIN SET;



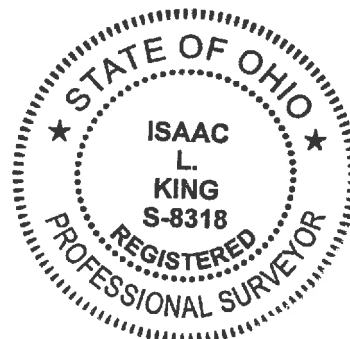
