**LEGAL DESCRIPTION OF A 3.221 ACRE PARCEL
FOR 4 DERR FARM LLC**

Being a parcel of land situated in part of the Northeast Quarter of Section 11, T-2-S, R-13-E, Salem Township, Wyandot County, Ohio, and further described as follows:

Commencing at a found stone marking the northeast corner of said Section 11 and the centerline of County Highway 42;

thence on an assumed bearing of N 88° 53' 23" W along the north line of said Section 11 and the centerline of said County Highway 42 a distance of 1340.61 feet to point marking the east line of the west half of the Northeast Quarter of said Section 11, referenced by a found iron pipe situated S 73° 32' 22" W a distance of 0.57 feet;

thence S 00° 01' 12" W along the east line of the west half of the Northeast Quarter of said Section 11 a distance of 865.53 feet to a found MAG nail marking the centerline of State Highway 199, passing a found iron rod for reference a distance of 781.42 feet;

thence S 45° 41' 50" E along the centerline of said State Highway 199 a distance of 283.51 feet to a set MAG nail and being the **POINT OF BEGINNING** of the hereinafter described parcel, referenced by a set iron rod situated N 44° 00' 00" E a distance of 52.04 feet;

thence N 44° 00' 00" E on a line a distance of 260.00 feet to a set iron rod, passing aforementioned set iron rod a distance of 52.04 feet;

thence N 66° 54' 03" E on a line a distance of 214.84 feet to a set iron rod;

thence N 90° 00' 00" E on a line a distance of 64.00 feet to a set iron rod;

thence S 00° 11' 44" E on a line a distance of 368.13 feet to a set iron rod;

thence S 58° 11' 13" W on a line a distance of 248.90 feet to a set MAG nail marking a spiral curve in the centerline of said State Highway 199, passing a set iron rod for reference a distance of 207.87 feet;

thence along a spiral curve to the left in the centerline of said State Highway 199 a distance of 173.78 feet to a found MAG nail marking the ST of said centerline, the chord of said spiral curve bearing N 45° 18' 51" W a chord distance of 173.78 feet and being referenced by a found iron rod situated S 44° 18' 10" W a distance of 45.00 feet;

thence continuing N 45° 41' 50" W along the centerline of said State Highway 199 a distance of 151.50 feet to a set MAG nail and being the **POINT OF BEGINNING**.

Containing in all 3.221 acres of land, more or less, of which 0.318 acre, more or less, is currently contained within highway right-of-ways. The above described property being subject to all legal highways and easements of record.

Bearings are assumed and are for angular measurement only.

All set iron rods are 5/8" diameter with personalized plastic caps.
