thence on an assumed bearing of N 00° 01' 15" E along the north-south half section line of said Section 31 a distance of 35.00 feet to a found iron rod marking a corner of a parcel of land now or formerly owned by the State of Ohio and being the **POINT OF BEGINNING** of the hereinafter described parcel;

thence S 89° 47' 20" W along the north line of said State of Ohio parcel a distance of 573.44 feet to a set iron rod;

thence N 29° 36' 52" W on a line a distance of 100.96 feet to set iron rod;

thence N 00° 01' 15" E on a line a distance of 430.00 feet to a set iron rod;

thence S 89° 47' 20" W on a line a distance of 264.00 feet to set iron rod marking an east line of a parcel of land now or formerly owned by M. Sheets or P. Sheets, Trustees;
