**LEGAL DESCRIPTION OF A 3.536 ACRE PARCEL
FOR DEREK BOOK**

Being a parcel of land situated in part of the Northeast and Northwest Quarters of Section 33, T-1-S, R-14-E, Tymochtee Township, Wyandot County, Ohio, and further described as follows:

Commencing at a found iron rod marking the north quarter post of said Section 33;

thence on an assumed bearing of S 00° 23' 20" E along the north-south half section line of said Section 33 (as occupied) a distance of 1033.70 feet to a set MAG nail marking the intersection of the north-south half section line with the centerline of County Highway 37 and marking a corner of a parcel of land now or formerly owned by B. Frobose, Etux. and being the **POINT OF BEGINNING** of the hereinafter described parcel;

thence continuing S 00° 23' 20" E along said north-south half section line of said Section 33 and along said B. Frobose, Etux. parcel a distance of 273.24 feet to a set iron rod marking a corner of said B. Frobose, Etux. parcel, passing a set iron rod a distance of 58.69 feet;

thence N 89° 09' 03" E along said B. Frobose, Etux. parcel a distance of 220.00 feet to a set iron rod;

thence S 00° 23' 20" E on a line a distance of 240.00 feet to a set iron rod;

thence S 80° 44' 33" W on a line a distance of 584.81 feet to a set MAG nail marking the centerline of said County Highway 37, passing a set iron rod a distance of 545.87 feet;

thence N 30° 21' 12" E along the centerline of said County Highway 37 a distance of 700.00 feet to the **POINT OF BEGINNING**.

Containing in all 3.536 acres of land, more or less, of which 0.456 acre, more or less, is currently contained within highway right-of-ways. The above described property being subject to all legal highways and easements of record.
