Commencing at a found MAG nail marking the intersection of the north-south half section line of said Section 13 and the centerline of Township Highway 18, referenced by a found iron rod situated N 00° 17' 29" E a distance of 16.50 feet;

thence on an assumed bearing of N 89° 42' 15" W along the centerline of Township Highway 18 a distance of 60.00 feet to a found MAG nail marking a corner of a parcel of land currently owned by F. T. Kin, et ux, and being the **POINT OF BEGINNING**, referenced by a found iron rod situated N 00° 17' 29" E a distance of 16.50 feet;

thence continuing N 89° 42' 15" W along said centerline a distance of 1269.88 feet to a point on the centerline of Township Highway 106, referenced by a found iron rod situated N 50° 45' 11" E a distance of 25.92 feet;

thence N 00° 14' 44" E along the centerline of Township Highway 106 a distance of 178.00 feet to a set MAG nail on or near the centerline of an open ditch, referenced by a set iron rod situated S 32° 11' 21" E a distance of 37.29 feet;

Commencing at a found nail marking the northwest corner of the northeast quarter of the southwest quarter of said Section 13 referenced by a found iron rod situated S 89° 46' 46" E a distance of 20.00 feet;

thence on an assumed bearing of S 00° 14' 44" W along the centerline of Township Highway 106 a distance of 469.71 feet a found MAG nail marking the southwest corner of a parcel of land currently owned by R. L. DuMonte, et ux, and being the **POINT OF BEGINNING**;

thence S 89° 46' 46" E along the south line of said DuMonte parcel a distance of 553.98 feet to a point on the west line of a parcel of land currently owned by F. T. Kin, et ux, passing a found iron rod a distance of 20.00 feet;
