Commencing at a set MAG nail marking the intersection of the centerline of a 16 foot wide alley on the south side of Merriman's Addition and the centerline of State Route 37 and referenced by a set iron rod situated N 60° 46' 33" E a distance of 49.90 feet;

thence along the centerline of State Route 37 an arc distance of 312.37 feet along a curve to the right having a radius of 1273.57 feet, a chord of 311.59 feet and a chord bearing of S 11° 12' 26" E to a found MAG nail and being the **POINT OF BEGINNING**;

thence N 71° 59' 16" E a distance of 226.62 feet to a found iron rod marking the northeasterly corner of a parcel of land currently owned by The Board of Trustees of Marseilles Township, passing a set iron rod a distance of 30.87 feet;

thence S 60° 24' 58" W along a northerly line of said Board of Trustees of Marseilles Township parcel a distance of 147.70 feet to a set iron rod marking a corner of said parcel;

thence N 88° 07' 45" W along a northerly line of said Board of Trustees of Marseilles Township parcel a distance of 87.12 feet to the **POINT OF BEGINNING**, passing a found iron rod a distance of 57.95 feet.
