**LEGAL DESCRIPTION OF A 96.253 ACRE PARCEL
FOR LOUISE QUAIL**

Being a parcel of land situated in part of the Southwest Quarter of Section 15 and the Southeast Quarter of Section 16, T-3-S, R-13-E, Mifflin Township, Wyandot County, Ohio, and further described as follows:

Commencing at a found iron rod marking the Southeast Corner of said Section 16 (Southwest Corner Section 15) and being the **POINT OF BEGINNING**;

thence on an assumed bearing of S $88^{\circ} 20' 57''$ W along the south line of said Section 16 a distance of 1812.06 feet to a point on the centerline of the Tymochtee Creek, passing a found iron rod a distance of 1322.13 feet and a set iron rod a distance of 1688.49 feet;

thence N $52^{\circ} 53' 58''$ W along the centerline of the Tymochtee Creek a distance of 338.30 feet to a point referenced by a set iron rod situated N $13^{\circ} 55' 45''$ E a distance of 33.00 feet;

thence N $75^{\circ} 23' 24''$ W along the centerline of the Tymochtee Creek a distance of 242.74 feet to a point referenced by a set iron rod situated N $10^{\circ} 12' 22''$ W a distance of 33.00 feet;

thence S 81° 41' 12" E along the centerline of the Tymochtee Creek a distance of 222.93 feet to a point referenced by a set iron rod situated S 36° 55' 45" W a distance of 30.00 feet;

thence S 47° 30' 48" E along the centerline of the Tymochtee Creek a distance of 101.90 feet to a point referenced by a set iron rod situated S 84° 46' 49" W a distance of 30.00 feet;

thence S 07° 38' 38" E along the centerline of the Tymochtee Creek a distance of 147.96 feet to a set MAG nail on the south line of Section 15 referenced by a set iron rod situated N 43° 57' 14" W a distance of 57.95 feet;

thence S 87° 35' 31" W along said section line a distance of 204.81 feet to the **POINT OF BEGINNING**.

Containing in all 96.253 acres of land, more or less, of which 1.782 acres, more or less, is currently contained within highway right-of-ways. The above described property being subject to all legal highways and easements of record.

Bearings are assumed and are for angular measurement only.

All set iron rods are 5/8" diameter with personalized plastic caps.
