Commencing at a found nail marking the East Quarter Post of said Section 15, referenced by a set iron rod situated S 61° 26' 29" W a distance of 68.61 feet;

thence on an assumed bearing of S 00° 27' 13" W along the centerline of Township Highway 1C, passing a found nail a distance of 33.00 feet, a total distance of 563.00 feet to a set MAG nail and being the **POINT OF BEGINNING**, referenced by a set iron rod situated N 89° 48' 32" W a distance of 33.00 feet;

thence continuing S 00° 27' 13" W along said centerline a distance of 758.21 feet to a found stone marking the northeast corner of a parcel of land currently owned by M. Hillier, et al;

thence N 89° 35' 29" W along the north line of said Hillier parcel a distance of 1328.19 feet to a set iron rod marking the northwest corner of said parcel, passing a set iron rod a distance of 33.00 feet;

thence on an assumed bearing of S 00° 27' 13" W along the centerline of Township Highway 10 a distance of 33.00 feet to a found MAG nail on the south line of the Wheeling and Lake Erie Railroad and being the **POINT OF BEGINNING**, referenced by a set iron rod situated N 89° 48' 32" W a distance of 60.00 feet;

thence continuing S 00° 27' 13" W along said centerline a distance of 530.00 feet to a set MAG nail;
