thence on an assumed bearing of N 00° 31' 36" W along the west line of said Section 4 a
distance of 1320.23 feet to a found iron rod on the north line of a parcel of land currently
owned by T. D. Sayre and M. K. Sayer, Trustees, and being the **POINT OF
BEGINNING**;

thence S 89° 30' 52" W along said line a distance of 70.71 feet to a found nail on the
centerline of State Highway 53, passing a set iron rod for reference a distance of 36.31
feet;

thence N 28° 48' 44" E along said centerline a distance of 144.32 feet to a point on the
east line of said Section 5;

thence S 00° 31' 36" E along said section line a distance of 125.86 feet to the **POINT OF
BEGINNING**, passing a set iron rod for reference a distance of 61.23 feet.

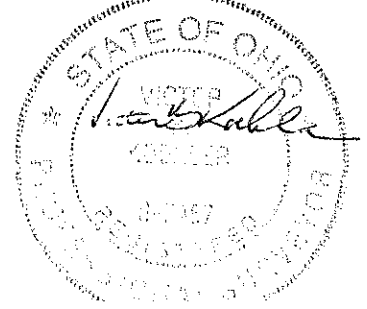

thence on an assumed bearing of N 00° 31' 36" W along the west line of said Section 4 a distance of 1320.23 feet to a found iron rod on the north line of a parcel of land currently owned by T. D. Sayre and M. K. Sayre, Trustees, and being the **POINT OF BEGINNING**;

thence continuing N 00° 31' 36" W along said section line a distance of 125.86 feet to a point on the centerline of State Highway 53, passing a set iron rod for reference a distance of 64.63 feet;
