Commencing at a found stone in a monument box marking the North Quarter Post of said Section 9;

thence on an assumed bearing of S 00° 00' 00" W along the centerline of Township Highway 79, passing a found MAG nail a distance of 575.56 feet, a total distance of 835.18 feet to a set MAG nail marking the southeast corner of a parcel of land currently owned by W. Blum, Jr., et ux, and being the **POINT OF BEGINNING**, referenced by a set iron rod situated N 90° 00' 00" W a distance of 30.00 feet;

thence continuing S 00° 00' 00" W along said centerline a distance of 483.36 feet to a set MAG nail marking the northeast corner of a parcel of land currently owned by G. & J. Yeater, Trustees;

thence S 89° 33' 15" W along said Yeater, Trustees parcel a distance of 1321.14 feet to a set iron rod marking the southeast corner of a parcel of land currently owned by L. Walton, et ux;

thence N 00° 06' 31" E along said Walton parcel a distance of 680.04 feet to a set iron rod;

thence N 89° 39' 01" E a distance of 915.83 feet to a set iron rod on the west line of the aforementioned Blum parcel;

thence S 00° 00' 00" W along said Blum parcel a distance of 191.98 feet to a set iron rod marking a corner of said parcel;

thence S 90° 00' 00" E along said Blum parcel a distance of 404.00 feet to the **POINT OF BEGINNING**, passing a set iron rod a distance of 374.00 feet.



thence on an assumed bearing of S 00° 00' 00" W along the centerline of Township Highway 79 a distance of 575.56 feet to a found MAG nail marking the northeast corner of a parcel of land currently owned by W. Blum, Jr. et ux;

thence N 90° 00' 00" W along said Blum parcel a distance of 404.00 feet to a found iron rod marking a corner of said Blum parcel, passing a found iron rod for reference a distance of 30.00 feet;

thence S 00° 00' 00" W along said Blum parcel a distance of 67.64 feet to a set iron rod;

thence S 89° 39' 01" W a distance of 915.83 feet to a set iron rod on the east line of a parcel of land currently owned by L. Walton, et ux;

thence N 00° 06' 31" E along said Walton parcel a distance of 640.74 feet to a found MAG nail on the centerline of Township Highway 42 marking a corner of said Walton parcel, passing a set iron rod for reference a distance of 610.74 feet;
