Commencing at a found iron rod on the east right-of-way line of Sandusky Avenue marking the Northwest corner of Lot 1 of Brinkerhoff's Addition to the City of Upper Sandusky;

thence on an assumed bearing of N 00° 03' 02" E along the east right-of-way line of Sandusky Avenue a distance of 198.47 feet to a found iron rod marking the southwest corner of a parcel of land currently owned by S. & L. Mawer and the northwest corner of a parcel of land currently owned by L. & P. Niederkohr;

thence S 89° 59' 48" E along a common line of said Mawer/ Niederkohr parcels a distance of 163.00 feet to a found iron rod and being the **POINT OF BEGINNING**;

thence N 00° 03' 02" E along a common line of said Mawer/ Niederkohr parcels a distance of 2.50 feet to a found drill hole in concrete;

thence S 89° 59' 48" E along a common line of said Mawer/ Niederkohr parcels a distance of 116.67 feet to a found iron rod;

thence S 00° 03' 02" W a distance of 0.60 feet to a set iron rod;

thence N 89° 59' 48" W a distance of 93.90 feet to a set iron rod;

thence S 00° 03' 02" W a distance of 1.61 feet to a set iron rod;

thence S 89° 16' 05" W along a common line of said Mawer/ Niederkohr parcels a distance of 22.77 feet to the **POINT OF BEGINNING**.
