LEGAL DESCRIPTION

Situated in the Village of Carey, County of Wyandot, State of Ohio, and being a part of the NW1/4 of Section 20, T1S, R13E, a tract of land bounded and described as follows:

Beginning at a mag nail found on the west line of the NE1/4 of said Section 20 and described as lying N01°16'34"E a distance of 755.76 feet from a monument box found marking the southwest corner of the NW1/4 of said Section 20, said beginning point referenced by a 5/8" iron pin found with Peterman Associates cap S88°52'10"E a distance of 30.00 feet, said beginning point also being the northwest corner of a 8.000 acre tract of land conveyed to Vaughn Property Services, LLC in OR 242, Page 197 of the Wyandot County Official Records;

thence along the west line of said NW1/4, also being the centerline of Township Highway 96 (R/W Varies) N01°16'34"E a distance of 360.00 feet to a mag nail set referenced by an iron pin set S88°52'10"E a distance of 30.00 feet;

thence S88°52'10"E a distance of 922.96 feet to an iron pin set, passing an iron pin set at 30.00 feet;

thence at right angles to the centerline of West Street (60' R/W) N01°07'50"E a distance of 210.00 feet to a mag nail set on the centerline of said West Street, passing an iron pin set for reference S01°07'50"W a distance of 30.00 feet;

thence along said centerline S88°52'10"E a distance of 60.00 feet to a mag nail set, referenced by an iron pin set S01°07'50"W a distance of 30.00 feet;

thence at right angles S01°07'50"W a distance of 210.00 feet to an iron pin set, passing an iron pin set at 30.00 feet;

thence parallel to the centerline of said West Street S88°52'10"E a distance of 379.97 feet to an iron pin set;

thence S01°10'01"W a distance of 448.12 feet to an iron pin set on the north line of a tract of land conveyed to David Heck, et al in Deed Volume 213, Page 367 of the Wyandot County Deed Records;

thence along said north line S73°45'48"W a distance of 227.03 feet to a iron pin found marking the northwest corner of said Heck, et al tract;

thence along the east line of said 8.000 acre tract of land N01°16'34"E a distance of 439.78 feet to an iron pin found with Peterman Associates cap;


