Situated in the Township of Tymochtee, County of Wyandot and State of Ohio and being part of the southeast quarter of Section 14, Township 1 South, Range 14 East, also being part of lands now or formerly owned by Richard E. and Lina M Sipe, as recorded in Official Record Volume 208, Page 656 of the Wyandot County Records and being more fully bounded and described as follows:

Commencing at a 3/4 inch rod found in a monument box at the southeast corner of said Section 14, said rod being on the centerline of State Route 103 (60 feet wide), thence South 89°04'49" West along said centerline and the southerly line of said Richard E. and Lina M Sipe parcel, a distance of 1264.90 feet to a mag nail set and being the Place of Beginning of the parcel of land herein described;

Course No. 1: thence South 89°04'49" West along the said centerline of State Route 103 and southerly line of said Sipe parcel, a distance of 58.70 feet to a mag nail set on the easterly line of a parcel of land now or formerly owned by Douglas E. Walton Trustee as recorded in Official Record Volume 172 Page 411 of the Wyandot County Records;

Course No. 2: thence North 00°01'20" East along the said easterly line of the Walton parcel, passing through an iron pin set at on the northerly right-of-way line of said State Route 103, a distance of 1018.41 feet to an iron pin set at a northeasterly corner said Walton parcel;

Course No. 3: thence South 89°21'52" West along a northerly line of the said Walton parcel, a distance of 1325.88 feet to an iron pin set on the westerly line of said southeast quarter of Section 14 and an easterly line of the said Walton parcel;

Course No. 4: thence North 00°08'08" West along said quarter section line, a distance of 413.04 feet to an iron pin set thereon;

Course No. 5: thence South 89°59'11" East along a new division line, a distance of 824.63 feet to an iron pin set;

Course No. 6: thence South 00°17'36" West along a new division line, a distance of 343.73 feet to an iron pin set;

Course No. 7: thence North 89°21'52" East along a new division line, a distance of 562.67 feet to an iron pin set;

Course No. 8: thence South 00°01'20" West along a new division line, passing an iron pin set on the northerly right-of-way line of said State Route 103, a distance of 1078.12 feet to the Place of Beginning of the lands herein described, containing 9.863 acres of land, 8.411 acres being part of Wyandot County Auditor's parcel number 38-1635-0000-00, and 1.452 acres being part of parcel number 38-1625-0000-00 of which 0.040 acre being part of State Route 103 right-of-way, as surveyed in October 2020 by Atwell,
