- At 4. Stone in barney road S 30° W 139 from 3
- At 5. Stake the south east corner of the N 2 NW 1/4 of Sec. 19 Tp. 2 S R. 14 E.
- At 6. Stone on east line of the N 2 NW 1/4 Sec. 19 Tp. 2 S R. 14 E.

- At 17. Stone on township line 120 chains north of 1/4 Post.
- At 18. Stone on township line 1310 chains north of 17

- At 20. Stone on east line of C.N.V. & P.R.R.
