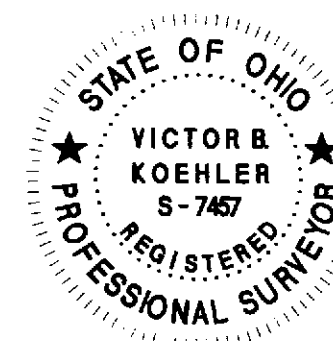
SECTION OVERVIEW NOT TO SCALE
