**LEGAL DESCRIPTION OF A 5.498 ACRE PARCEL
FOR NANCY GRUBBS**

Being a parcel of land situated in part of the Northeast and Southeast Quarters of Section 11, T-2-S, R-12-E, Richland Township, Wyandot County, Ohio, and further described as follows:

Commencing at a found stone marking the northeast corner of said Section 11 and the intersection of the centerlines of Township Highway 42 and County Highway 91;

thence on an assumed bearing of S 00° 00' 00" E along the east line of said Section 11 and the centerline of said County Highway 91 a distance of 2123.77 feet to a set MAG nail and being the **POINT OF BEGINNING** of the hereinafter described parcel, referenced by a set iron rod situated N 89° 48' 30" W a distance of 20.00 feet;

thence continuing S 00° 00' 00" E along the east line of said Section 11 and the centerline of said County Highway 91 a distance of 573.00 feet to a set MAG nail;

thence N 89° 48' 30" W on a line a distance of 418.00 feet to a set iron rod, passing a set iron rod a distance of 20.00 feet;

thence N 00° 00' 00" W on a line a distance of 573.00 feet to a set iron rod;

thence S 89° 48' 30" E on a line a distance of 418.00 feet to the **POINT OF BEGINNING**, passing a set iron rod a distance of 398.00 feet.

Containing in all 5.498 acres of land, more or less, of which 0.263 acre, more or less, is currently contained within highway right-of-ways. The above described property being subject to all legal highways and easements of record.

Bearings are assumed and are for angular measurement only.

All set iron rods are 5/8" diameter with personalized plastic caps.
