**LEGAL DESCRIPTION OF A 40.000 ACRE PARCEL
FOR CAROL HOLLANSHEAD**

Being a parcel of land situated in part of the Southwest Quarter of Section 12, T-3-S, R-13-E, Mifflin Township, Wyandot County, Ohio, and further described as follows:

Commencing at a found stone marking the southwest corner of said Section 12 and the intersection of the centerlines of County Highway 108 and County Highway 58 and being the **POINT OF BEGINNING** of the hereinafter described parcel;

thence on an assumed bearing of N 00° 18' 23" E along the west line of said Section 12 and the centerline of said County Highway 108 a distance of 1279.36 feet to a set MAG nail;

thence S 89° 36' 42" E on a line a distance of 1361.96 feet to a set iron rod marking the west line of the east half of the southwest quarter of said Section 12, passing a set iron rod a distance of 30.00 feet;

thence S 00° 18' 30" W along the west line of the east half of the southwest quarter of said Section 12 a distance of 1279.36 feet to a set MAG nail marking the south line of said Section 12 and the centerline of said County Highway 58, passing a set iron rod a distance of 1249.36 feet;

thence N 89° 36' 42" W along the south line of said Section 12 and the centerline of said County Highway 58 a distance of 1361.92 feet to the **POINT OF BEGINNING**.

Containing in all 40.000 acres of land, more or less, of which 1.798 acre, more or less, is currently contained within highway right-of-ways. The above described property being subject to all legal highways and easements of record.

Bearings are assumed and are for angular measurement only.

All set iron rods are 5/8" diameter with personalized plastic caps.
