**LEGAL DESCRIPTION OF A 13.000 ACRE PARCEL

Being a parcel of land situated in part of the Southeast Quarter of Section 36, T-3-S, R-12-E, Jackson Township, Wyandot County, Ohio, and further described as follows:

Commencing at a found stone marking the southeast corner of said Section 36 and the centerline of County Highway 95;

thence on an assumed bearing of N 00° 46' 02" E along the east line of said Section 36 and the centerline of said County Highway 95 a distance of 802.36 feet to a set MAG nail;

thence N 88° 36' 04" W on a line a distance of 435.63 feet to a set iron rod and being the **POINT OF BEGINNING** of the hereinafter described parcel, passing a set iron rod a distance of 25.00 feet;

thence continuing N 88° 36' 04" W on a line a distance of 784.04 feet to a set iron rod marking a southeasterly line of a parcel of land now or formerly owned by N. Jon Hoy;

thence N 49° 49' 28" E along said N. Jon Hoy parcel a distance of 1614.58 feet to a set MAG nail marking the east line of said Section 36 and the centerline of said County Highway 95, passing a set iron rod a distance of 1581.48 feet;

thence S 00° 46' 02" W along the east line of said Section 36 and the centerline of said County Highway 95 a distance of 871.49 feet to a set MAG nail;

thence N 88° 36' 04" W on a line a distance of 435.63 feet to a set iron rod, passing a set iron rod a distance of 25.00 feet;

thence S 00° 46' 02" W on a line a distance of 200.00 feet to the **POINT OF BEGINNING**.

Containing in all 13.000 acres of land, more or less, of which 0.494 acre, more or less, is currently contained within highway right-of-ways. The above described property being subject to all legal highways and easements of record.
