**LEGAL DESCRIPTION OF A 1.131 ACRE PARCEL  
FOR BEN PORTER**

Being a parcel of land situated in part of the Northeast Quarter of Section 32, T-3-S, R-15-E, Antrim Township, Wyandot County, Ohio, and further described as follows:

Commencing at a found railroad spike marking the intersection of the west line of said Section 32 and the centerlines of County Highway 130 and State Highway 294, referenced by a found iron rod situated N 33° 41' 24" E a distance of 36.06 feet;

thence on an assumed bearing of N 90° 00' 00" E along the centerline of said State Highway 294 a distance of 2765.61 feet to a found MAG nail marking a corner of a parcel of land now or formerly owned by Ben Porter, Etux. and being the **POINT OF BEGINNING** of the hereinafter described parcel;

thence N 00° 08' 19" E along said Ben Porter, Etux. parcel a distance of 535.68 feet to a found iron rod marking a corner of said Ben Porter, Etux. parcel, passing a found iron rod a distance of 30.00 feet;

thence S 89° 38' 34" E along said Ben Porter, Etux. parcel a distance of 126.57 feet to a found iron rod marking a corner of said Ben Porter, Etux. parcel;

thence N 01° 35' 15" E along said Ben Porter, Etux. parcel a distance of 277.20 feet to a found iron rod marking a corner of said Ben Porter, Etux. parcel;

thence N 87° 51' 15" W along said Ben Porter, Etux. parcel a distance of 176.25 feet to a found iron rod marking a corner of said Ben Porter, Etux. parcel;

thence N 01° 09' 09" E along said Ben Porter, Etux. parcel a distance of 77.83 feet to a set iron rod;

thence S 87° 41' 01" E on a line a distance of 182.75 feet to a set iron rod;

thence S 00° 17' 12" W on a line a distance of 568.00 feet to a set iron rod;

thence N 88° 21' 13" W on a line a distance of 136.00 feet to a set iron rod;

thence S 00° 57' 11" E on a line a distance of 324.97 feet to a set MAG nail marking the centerline of said State Highway 294, passing a set iron rod a distance of 294.97 feet;

thence S 90° 00' 00" W along the centerline of said State Highway 294 a distance of 10.20 feet to the **POINT OF BEGINNING**.

Containing in all 1.131 acres of land, more or less, of which 0.007 acres, more or less is currently contained within highway right-of ways. The above described property being subject to all legal highways and easements of record.

Bearings are assumed and are for angular measurement only.

All set iron rods are 5/8" diameter with personalized plastic caps.
